Pursuant to Regulation 30 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 ("LODR Regulations"), we wish to inform you that, the Company has received an Order dated December 2, 2023, from the Joint Commissioner GST, Corporate Circle, Lucknow, basis the scrutiny of returns for the period from July 2017 to March 2018 for Uttar Pradesh GSTIN for a Tax demand of Rs. 2,80,76,428/-, Interest of Rs. 3,20,07,127/- and Penalty of Rs. 28,07,642/- aggregating to a total demand of Rs. 6,28,91,197/-

Based on our assessment, we believe that the said demand is not maintainable, and the Company is in the process of preferring an appeal against the said Order. The order has no material impact on the financials, operations or other activities of the Company.
