तत्कालीन पंतप्रधान इंदिरा गांधींनी ‘इंजियेटेड गाडेड मिसाइल डेव्हलपमेंट प्रोग्रॅम’ १९८३ मध्ये सुरू केला होता. पुढे पंतप्रधान राजीव गांधींनी क्षेत्राखनिर्मितीच्या या प्रकल्पास गती दिली व १९८५ मध्ये कमी पल्ल्याच्या या अतिवेगवान क्षेपणास्त्रांची पहिली चाचणी केली गेली. आगामी युद्धे ही परंपरागत युद्धापेक्वी ‘मिसाईल वॉर’ असतील याची जाणीव झाल्यामुळेच इंदिरा व राजीव यांनी क्षेपणास्त्र विकासावर जाणीवपूर्वक भर दिला. त्यातूनच त्रिशूल (१९८५), पृथ्वी (१९८८), नाग (१९८८), अग्नी (१९८९) आणि आकाश (१९९०) या क्षेपणास्त्रांचा जन्म झाला.

आता पाकिस्तानवर भारतीय सैन्याने केलेल्या लष्करी कारवाईत महत्त्वाची भूमिका पार पाडणारे ब्राम्होस हे क्षेपणास्त्रही याच मालिकेतून पुढे साकारले गेले. २००१ मध्ये त्याची यशस्वी चाचणी झाली होती. आपल्या आजच्या युद्ध सज्जतेची पायाभरणी इंदिरा आणि राजीव यांनी सुमारे ४० वर्षांपूर्वीच केली हे विशेष. इंदिरा गांधींच्या हत्येनंतर पंतप्रधान झालेले राजीव गांधी यांनी ‘मेरा भारत महान’ हे स्वप्न पाहिले आणि त्या दृष्टीने खास धोरण आखून कोट्यवधी भारतीयांच्या जीवनात नवी उमेद दिली. देशात संगणक आणि दूरसंचार क्रांती करून त्यांनी भारताला खऱ्या अर्थाने एकविसाव्या शतकात नेले. आज आपल्या देशात कोट्यवधी तरुण-तरुणींचे जीवन संगणकांशी निगडीत आहे, तर इंटरनेट, मोबाईल, व्हॉट्सअॅप, इन्स्टाग्राम, फेसबुक, एक्स याशिवाय आपले पान हलत नाही. गांधींनी दूरदृष्टीने केलेले संगणक व दूरसंचार क्षेत्रातील धोरण क्रांतिकारी ठरले. राजीव यांनी सेंटर फॉर

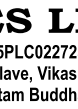

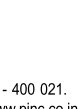
